Carlo is a Quantity Surveyor who specialises in establishing entitlement for both quantum and time matters with a particular focus on project strategy and dispute resolution.

Commencing his career as an architectural steel fabricator specialising in bespoke steelwork where he gained a wealth of practical site experience, Carlo quickly progressed his career and was offered a position as a Quantity Surveyor for an M&E contractor, before moving to a Quantity Surveying practice.

Carlo has performed a variety of roles such as estimator, procurement manager, commercial manager and contract administrator. This breadth of experience has given Carlo a keen eye to analyse construction projects and establish entitlement. Carlo has a detailed understanding of the use and administration of all major standard form contracts and has provided guidance at all stages of construction projects.

Since joining Tudor Rose, Carlo has provided contractual and commercial advice to clients, contractors and subcontractors alike. He is frequently appointed by his clients to provide strategic support on live commissions with a focus on the identification and management of commercial risk. Assignments and Achievements

2018: Provide strategic support to main contractor in a dispute regarding the correct assessment of compensation events on the installation of a new water main with a contract sum of £85m. Carry out analysis of disputed compensation events, establish correct means of assessment and oversee implementation project wide. Support project team through the negotiated settlement of the dispute and agreement of terms. Implement new processes across project and provide on-going support to the team.

2018: Undertook independent analysis of damages incurred by main contractor consequential on negligent design of pipework as part of a water treatment facility under a bespoke services agreement. Establish the losses, incurred organise experts as necessary and oversee measurement of quantum and assessment of delay. Prepare report for use in mediated settlement.

2018: Representation of main contractor in adjudication in respect of the correct assessment of compensation events under NEC3 option B. Undertook forensic delay analysis of delays and successfully secured an extension to the completion date.

2014: Representation of an Employer in a dispute with the Contractor under JCT SBC/Q. Critical analysis of all Subcontractor accounts and identification of key areas in dispute. Preparation of associated forensic reports for use in litigation proceedings.

Establish entitlement and preparation of Main Contractor's own claim for damages as a result of Subcontractor breach.

2012: Project Manager, Contract Administrator on behalf of client for overhaul of systems in an operational site (value approx. £2m) using Client's bespoke contract. Responsible for procurement and management of the replacement machine hall cooling system in business-critical location including liaising with all stakeholders and ensuring minimal disruption to site operation.

2010 - 2011: Quantity Surveyor for £46m mixed use development in Guernsey using bespoke Construction Management Contract acting on behalf of the client during dispute with the Construction Manager. Responsible for successfully negotiating settlement of Mechanical, Electrical, Landscaping, Joinery, Steel Fabrication packages achieving a saving of approx. 25% over Construction Manager recommendations. He was also responsible for preparation of quantum claims of the aforementioned packages for use by the client in dispute procedure.
